BACKGROUND AND EXPERIENCE

As the founder and managing member of Marks & Sokolov LLC, Bruce has earned an international reputation as a litigator on matters involving the Russian Federation, Ukraine, and the West since 1998. He is known for his skilled trial advocacy and legal strategy in the U.S. and abroad. Bruce has successfully represented Russian and Western clients in commercial arbitration and civil litigation matters, with cases involving billions of dollars. He has engaged in groundbreaking litigation in which Russian bankruptcies were recognized under the U.S. Bankruptcy Code and Russian judgments were recognized and enforced in the United States. He represents plaintiffs and defendants.

KEY INTERNATIONAL ARBITRATION EXPERIENCE

London Court of International Arbitration

- Represented a subsidiary of a leading Russian gold mining company which purchased a target mining company in Kazakhstan. Persons related to the sellers then commenced arbitration against the target under contracts seeking payment of about \$70 million. Marks' client argued that the contracts were shams, designed to enrich former controlling persons of the target and made a counterclaim to claw back payments made under those contracts. In fraud litigation in the U.K., Marks was successful in obtaining a world-wide freezing order for several hundred million dollars, comprehensive search warrants for the sellers' premises and electronic devices, and a stay of the arbitration until a global settlement.
- Represented a prominent Ukraine businessmen against a Russian entrepreneur in a dispute related to the improper seizure of control in Ukrainian energy companies. Marks oversaw pre-arbitration injunction proceedings in Cyprus, and arbitration in England. The injunction remained in force during the arbitration.

Arbitration Institute of the Stockholm Chamber of Commerce

- Represented French and American claimants in an arbitration against a Russian buyer in a breach of contract claim and obtained an award for damages.
- Represented a trading partner of a Russian aluminum producer in arbitration proceedings with a breach of contract claim for the failure to pay for delivered goods. The case settled with payment.

Represented a trading partner of a Russian aluminum producer in an arbitration with a \$10 million claim in damages for lost profits and business disruption resulting from bankruptcy proceedings of the Russian plant.

International Chamber of Commerce in Paris

 Defeated a \$6.5 million arbitration claim by an American company against Marks' Ukrainian controlled client related to the cancellation of a contract to dismantle a steel mill in Ohio for shipment to Ukraine.
